While this particular mulch has been removed, pet owners need to appreciate that no mulch is meant to be eaten and that dogs and what they eat are the responsibility of the owner and not the park.

Pond Outlet Pipe - Charlie did great job and as promised, it was under \$1000. A new pipe has been added and the area has been graded. Remaining pieces of pipe are rusty and they're not buried deep enough and will eventually need to be replaced.

Eagle scout projects - coming along beautifully. The gazebo is looking good, the fire pit is beautiful, railings have been replaced and the benches look really solid. We will have new signage on the trails soon. trails -
