- g. Dog poop: Livy will be out of town and needs help with removal. Donna and Dave will help out.
- h. Signs have been posted in the park advertising a dog walking service at the park. Livy suspects signs have been placed by students. Since no service has been approved, this service violates park policy. Livy will call the posted number.

#### 6. Publicity:

a. Due to recent board resignations we need two new people to host the site. Paul Hanson from EcoPixel trained two board members, Tom and Dan, to monitor and update the website.

#### 7. Board vacancies:

#### 8. Events

- b. A park user has asked to reserve the pavilion for a birthday party on Aug. 29. She wants to bring in a bouncy house. Jim moved to approve the bouncy house. Dave seconded. Dave-no, Jim-no, Livy-no, Tom-no. Motion not approved.
- 10. Tom moved to adjourn. Dave seconded. Motion approved. Jim-yes, Dave-yes, Livy-yes, Donna-yes, Tom-yes. Motion approved. Meeting adjourned at 8:09.
