### 5. Park management

- A. Bruce gave an update on the Covered Bridge renovation project
  - (1) Bridge superstructure will be removed soon.
  - (2) B&C will build new handrails before anything is removed. When handrails are installed.
  - (3) No news from EV
  - (4) There are quite a few plaques and signs that have to be removed before the superstructure comes down. Bruce, Dave and Jim will do this work on Sat morning at 9:00

- C. 2 Port-o-lets will be removed ASAP. The remaining port-o-let will be removed by the first week of Dec. Livy will call P&P

- E. People count for October is 21,500. 346 per day.
- F. Report on the beaver damage
  - (1) Bruce has contacted Ginko Tree Service about cutting down several cottonwood trees near the Browns River. The trees have been girdled by the beaver and will not live.
  - (2) Gingko Tree Service will come out and evaluate taking down these large trees at the river
- G. Camden Yandow has requested permission to do an Eagle Scout project at the park. He wants to build a bench overlook. Donna suggested building an information kiosk near the entrance. This is a greater need than a bench. Livy will discuss the idea with him
- H. Kirk Peterson contacted Livy again regarding art sculptures in the park. We responded that the JUPD does not wish to to become the fiscal agent for any outside groups, as his group suggested
- 6. ERSA Grant proposals for trail work are due Nov. 29. We will be submitting an application asking for \$62,000. Donna, Bruce and Livy are working with Sherry Winnie on the project.
